# 2025–2026 QUICK STEP PLUS COLLEGE ALGEBRA ENROLLMENT GUIDE FOR HIGH SCHOOL STUDENTS

QSPCA is an independent study self-paced course, not a College Now course. Your college grade is determined by assessment of the course material by a JCCC professor. (This may be a different grade from the high school grade.) To earn college credit, complete the steps below.

- 1. APPLY for admission once by going to admissions.jccc.edu to start your application. To ensure your eligibility to enroll before the deadline, apply no later than the priority date listed on the calendar in this publication. When your application is processed, you will receive an email that includes your JCCC ID number and login information.
- 2. PLACEMENT into a College Algebra class. You can place into College Algebra if you have one of the following:
  - a grade of "B-" or higher in the second semester of a high school course identified as equivalent to or higher than Algebra II or Integrated Math 3 and a high school unweighted GPA of 3.25 or higher
  - an ACT math score of 22 or higher
  - an ACT math score of 20 or 21 and a high school unweighted GPA of 3.25 or higher
  - an ALEKS PPL assessment score of 46 or higher
  - an ALEKS PPL assessment score of 42 and a high school unweighted GPA of 3.25 or higher

Go to **jccc.edu/QuickStepPlus** to upload your high school transcript and/or ACT score report or Schedule Placement Test if you need to take the ALEKS PPL assessment with JCCC Testing Services.

- **3. ENROLL** in classes online or by phone, for enrollment deadline dates, see the calendar in this publication.
  - To enroll online, you will need the appropriate five-digit CRN number for your high school.
  - Log in to MyJCCC, select the Enroll and Pay card, then click Add/Drop Classes links.
  - Select the term "Credit Fall" for fall enrollment.
  - Select the Enter CRNs tab on the top left, enter the five-digit CRN number for your course, click Add to Summary, then click Agree & Submit.
  - Confirm that your courses show a status of Registered to ensure your enrollment was successful.
- 4. PAY tuition at the time of enrollment. Tuition may be paid online by logging in to MyJCCC and select the Enroll and Pay card. For more information about paying tuition, tuition rates, financial assistance or grant opportunity, and student financial responsibility, go to jccc.edu/CollegeNowPayment. No payments can be accepted by phone. Students are financially responsible for all charges on their account.

# **2025–2026** QUICK STEP PLUS COLLEGE ALGEBRA CALENDAR

### **AUGUST 2025**

- **25** Fall Quick Step Plus College Algebra enrollment opens
- 27 Application priority submission deadline\* (select summer/fall 2025 admissions term)

### **SEPTEMBER 2025**

- Priority deadline\* to submit ACT test scores and/or high school transcripts for placement waiver requests, or to complete ALEKS PPL assessment, if applicable.
- 22 Last day to enroll in a Quick Step Plus College Algebra course

### **OCTOBER 2025**

- 6 Last day to drop a Quick Step Plus College Algebra course and receive 100% refund
- 20 Last day to drop a Quick Step Plus College Algebra course without a withdrawal (W) on the student's permanent record

### **MARCH 2026**

- 2 Last day to withdrawal with a "W" on transcript or request pass/fail grade option
- \*Admissions application, placement waivers, and ALEK PPL assessment will be accepted after the priority deadline; however, JCCC cannot guarantee they will be processed before the enrollment deadline.
